COMMISSIONER PROCEEDINGS REGULAR MEETING JULY 24, 2023

THE BOARD OF COMANCHE COUNTY COMMISSIONERS MET IN REGULAR SESSION AT 9:00 A.M., MONDAY, JULY 24, 2023 IN ROOM 302 OF THE COMANCHE COUNTY COURTHOUSE, LAWTON, OKLAHOMA.

CHAIRMAN JOHNNY OWENS CALLED THE MEETING TO ORDER AND COUNTY CLERK, CARRIE TUBBS CALLED THE ROLL. PRESENT WERE JOHNNY OWENS AND JOHN O'BRIEN. JOSH POWERS WAS ABSENT.

ROBBIE TRAUGHBER GAVE THE INVOCATION AND JOHNNY OWENS LED THE AUDIENCE IN THE PLEDGE OF ALLEGIANCE.

O'BRIEN MOVED TO APPROVE THE ACCEPTANCE OF THE MINUTES OF JULY 17, 2023. OWENS SECONDED THE MOTION WITH O'BRIEN AND OWENS VOTING AYE. NO NAY VOTES.

DISCUSSION AND POSSIBLE ACTION REGARDING THE AMERICAN RESCUE PLAN ACT OF 2021 (ARPA). NO ACTION TAKEN.

OWENS MOVED TO TABLE DISCUSSION AND POSSIBLE ACTION PERTAINING TO THE MATTERS OF THE COMANCHE COUNTY PRE-TRIAL RELEASE PROGRAM AND THE ADMINISTRATOR, COURT RELATED SERVICES, INC. AND MORE SPECIFICALLY FINANCIAL MATTERS RELATED TO INVOICE SUBMITTAL DURING THE TIME PERIOD OF APRIL, 2023 AND MAY, 2023. O'BRIEN SECONDED THE MOTION WITH OWENS AND O'BRIEN VOTING AYE. NO NAY VOTES.

O'BRIEN MOVED TO APPROVE ACCEPTING A DONATION FROM THE OKLAHOMA BAR FOUNDATION FOR A GRANT AWARDED TO THE COMANCHE COUNTY DISTRICT COURT FOR THE PURPOSE OF PURCHASING FOUR (4) STENO MACHINES AND SEVEN (7) AUDIO BACKUP EQUIPMENT. THE DONATION REQUEST WAS SUBMITTED BY JUDGE EMMITT TAYLOE AND THE AWARDED GRANT IS IN THE AMOUNT OF \$64,474.00. OWENS SECONDED THE MOTION WITH O'BRIEN AND OWENS VOTING AYE. NO NAY VOTES.

O'BRIEN MOVED TO APPROVE A CHIP SEAL PLANS PROPOSAL FROM CEC CORPORATION FOR PROFESSIONAL ENGINEERING SERVICES TO INCLUDE DESIGN SERVICES ASSOCIATED WITH CHIP SEAL OVERLAY OF ROUTES 6643 AND 7006, IN COMANCHE COUNTY DISTRICT #1, IN THE AMOUNT OF \$3,696.00. OWENS SECONDED THE MOTION WITH O'BRIEN AND OWENS VOTING AYE. NO NAY VOTES.

O'BRIEN MOVED TO APPROVE AMERICAN CORRECTIONAL ASSOCIATION REACCREDITATION CONTRACT BY AND BETWEEN THE AMERICAN CORRECTIONAL ASSOCIATION AND COMANCHE COUNTY BOARD OF COMMISSIONERS ON BEHALF OF THE COMANCHE COUNTY JUVENILE BUREAU, TO IMPROVE CORRECTIONAL AGENCIES BY PROMOTING BEST PRACTICES FOR JUVENILE DETENTION CENTERS THROUGH A PROCESS OF ACCREDITATION. CONTRACT SHALL BE EFFECTIVE UPON SIGNING, AND SHALL REMAIN IN FULL FORCE UNTIL THE EARLIER OF 3 YEARS AFTER REACCREDITATION IS GRANTED OR THE

CONTRACT IS TERMINATED. FEE FOR REACCREDITATION WILL BE IN THE AMOUNT OF \$14,500.00. OWENS SECONDED THE MOTION WITH O'BRIEN AND OWENS VOTING AYE. NO NAY VOTES.

OWENS MOVED TO APPROVE ACKNOWLEDGEMENT OF LETTER DATED JUNE 29, 2023 FROM CINDY CONNER, WEST DISTRICT INTERIM DIRECTOR WITH OSU EXTENSION, ADVISING THE COMANCHE COUNTY BOARD OF COMMISSIONERS THAT CAROL HART, EXTENSION EDUCATOR, FCS/4-H, WILL SERVE AS COUNTY EXTENSION DIRECTOR FOR COMANCHE COUNTY, IN PLACE OF

TREVOR VAUGHN, WHO RESIGNED HIS POSITION. O'BRIEN SECONDED THE MOTION WITH OWENS AND O'BRIEN VOTING AYE. NO NAY VOTES.

OWENS MOVED TO TABLE OPEN WRITTEN BID #WB24-01 – RE-ROOF THE PRAIRIE BUILDING AT THE COMANCHE COUNTY FAIRGROUNDS, LAWTON, OK. BID RECEIVED IN THE AMOUNT OF \$113,262.00 FROM BRADLEY FOAM ROOFING LLC. O'BRIEN SECONDED THE MOTION WITH OWENS AND O'BRIEN VOTING AYE. NO NAY VOTES.

O'BRIEN MOVED TO APPROVE A MATERIAL & INSTALLATION AGREEMENT, BONDS AND CERTIFICATES OF INSURANCE FOR AMERICAN ELEVATOR CO, INC. FOR THE ELEVATOR MODERNIZATION PROJECT AT THE COMANCHE COUNTY COURTHOUSE. (BID #43 – AWARDED 6/26/2023). OWENS SECONDED THE MOTION WITH O'BRIEN AND OWENS VOTING AYE. NO NAY VOTES.

OWENS MOVED TO APPROVE A RESOLUTION DESIGNATING TAX EXEMPT STATUS TO AMERICAN ELEVATOR CO., INC. AND ITS SUB-CONTACTORS AS AN AGENT FOR THE COUNTY FOR THE PURPOSES OF PURCHASING MATERIALS AND TANGIBLE PERSONAL PROPERTY TO BE USED FOR THE ELEVATOR MODERNIZATION PROJECT AT THE COMANCHE COUNTY COURTHOUSE. TERM OF AGREEMENT IS FROM THE DATE OF EXECUTION THRU JUNE 30, 2024 AND THE FEE FOR SERVICE IS \$16.00 PER HAIRCUT SESSION.

TERM OF AGREEMENT IS FROM THE DATE OF EXECUTION THROUGH JUNE 30, 2024 AND FEE FOR SERVICES IS \$700.00 PER QUARTER PLUS THE COST OF FILTERS AND MATERIALS.

TERM OF AGREEMENT IS FROM THE DATE OF EXECUTION THRU JUNE 30, 2024 AND THE FEE FOR SERVICES IS \$125.00 PER ONE (1) HOUR SESSION PER "POD" NOT TO EXCEED TWO (2) HOURS PER WEEK.
