COMMISSIONER PROCEEDINGS REGULAR MEETING AUGUST 7, 2023

THE BOARD OF COMANCHE COUNTY COMMISSIONERS MET IN REGULAR SESSION AT 9:00 A.M., MONDAY, AUGUST 7, 2023 IN ROOM 302 OF THE COMANCHE COUNTY COURTHOUSE, LAWTON, OKLAHOMA.

CHAIRMAN JOHNNY OWENS CALLED THE MEETING TO ORDER AND COUNTY CLERK, CARRIE TUBBS CALLED THE ROLL. PRESENT WERE JOHNNY OWENS, JOSH POWERS AND JOHN O'BRIEN. NONE WERE ABSENT.

ROBBIE TRAUGHBER GAVE THE INVOCATION AND JOHNNY OWENS LED THE AUDIENCE IN THE PLEDGE OF ALLEGIANCE.

OWENS MOVED TO APPROVE THE ACCEPTANCE OF THE MINUTES OF JULY 31, 2023. POWERS SECONDED THE MOTION WITH OWENS, POWERS AND O'BRIEN VOTING AYE. NO NAY VOTES.

DISCUSSION AND POSSIBLE ACTION REGARDING THE AMERICAN RESCUE PLAN ACT OF 2021 (ARPA). NO ACTION TAKEN.

O'BRIEN MOVED TO APPROVE DISCUSSION AND POSSIBLE ACTION REGARDING THE ACCEPTANCE AND APPROVAL OF THE CURRENT COMANCHE COUNTY ARPA FUNDS BUDGET DRAFT, RECEIVED BY FLOYD AND DRIVER, PLLC, ON AUGUST 3, 2023, WHICH LISTS PROJECTS THAT HAVE BEEN APPROVED AND AWARDED GRANTS, UNDER THE AMERICAN RESCUE PLAN ACT OF 2021 (ARPA). THIS BUDGET LIST INCLUDES THE ADDITION OF SNOW REMOVAL EQUIPMENT FOR ALL THREE (3) DISTRICTS. THE REMAINING FUNDS UNDER THE GENERAL GOVERNMENT CATEGORY WILL BE DIVIDED EQUALLY BETWEEN THE THREE (3) DISTRICTS. POWERS SECONDED THE MOTION WITH O'BRIEN, POWERS AND OWENS VOTING AYE. NO NAY VOTES.

OWENS MOVED TO APPROVE RE-APPOINTING DR. ROSEMARY BELLINO, M.D. AS A MEMBER OF THE COMANCHE COUNTY BOARD OF HEALTH. TERM OF OFFICE SHALL BE EFFECTIVE IMMEDIATELY AND EXPIRE JUNE 30, 2027. O'BRIEN SECONDED THE MOTION WITH OWENS AND O'BRIEN VOTING AYE. NO NAY VOTES. POWERS ABSTAINED FROM VOTING.

O'BRIEN MOVED TO APPROVE THE COMANCHE COUNTY COMMISSIONERS' MEETING SCHEDULE FOR THE YEAR 2024. POWERS SECONDED THE MOTION WITH O'BRIEN, POWERS AND OWENS VOTING AYE. NO NAY VOTES.

POWERS MOVED TO APPROVE THE COMANCHE COUNTY COURTHOUSE HOLIDAY SCHEDULE FOR THE YEAR 2024. O'BRIEN SECONDED THE MOTION WITH POWERS, O'BRIEN AND OWENS VOTING AYE. NO NAY VOTES.

APPROVE RENEWING COMANCHE COUNTY REGIONAL JUVENILE DETENTION CENTER (CCRJDC) PROFESSIONAL SERVICE AGREEMENT BY AND BETWEEN THE BOARD OF COUNTY COMMISSIONERS OF COMANCHE COUNTY, STATE OF OKLAHOMA ON BEHALF OF CCRJDC AND JAIMEE DEEL TO WORK UNDER THE DIRECTION OF THE DETENTION CENTER PHYSICIAN AND THE GENERAL SUPERVISION OF THE DETENTION FACILITY SUPERINTENDENT TO CONDUCT RESIDENT MENTAL HEALTH ASSESSMENTS. AGREEMENT SHALL TERMINATE ON JUNE 30, 2024.
